# SAG-AFTRA/JPC 2022 Commercials Contract MPU & Holding Fee Examples



### **MPU & Holding Fee Examples**

#### What are the new MPU and holding fees changes?

Most of the rules for MPU and holding fees haven't changed, except that an advertiser or agency now has **13 weeks after the last production day** or **the first commercial airdate** (whichever occurs first) to initiate a use cycle (excluding recalls and retakes which will be ignored for the purpose of calculating the MPU). Previously the MPU was calculated 13 weeks from the first shoot day. This change means that a commercial can be finished without cutting into the 21-month use period as much as it did previously with past contracts.

Holding fees are paid to hold the performer exclusive to a category of product or service and/or in order to use a commercial in nonconsecutive use cycles. The holding fee amount is still equal to a session fee, and the session fee still serves as the first holding fee. An advertiser or agency then has 13 weeks after the last production day to initiate a use cycle. If no use is initiated, a holding fee is due to the performer. Thereafter, a holding fee is due every 13 weeks unless a commercial is in a 1-year use cycle, otherwise it's paid and credited against the use cycle. Additionally, holding fees may be credited against all media types.


For commercials produced under 'Linear' and 'Linear + Digital' (includes streaming), holding fees **are automatic**. As a result, nonconsecutive use cycles are always permitted. For commercials that fall under the 'Digital Only' category the contract (which includes Traditional Digital and Gaming, AR or Virtual Worlds, & Emerging Platforms - but not streaming), holding fees **are not automatic**. For Traditional Digital, producers can use the commercial in nonconsecutive cycles as long as they are paying holding fees to the principal performers. For Gaming, AR or Virtual Worlds, & Emerging Platforms, holding fees can be freely bargained.



| 8        | 4 wks, 4<br>wks             | This example shows when holding fees are due after <b>paying 4 weeks of traditional digital followed by 4 weeks of local cable</b> in the same cycle.   |



Note: Since the employment occurred under the "Linear and Linear + Digital" side of the contract, exclusivity is automatic throughout the MPU and holding fees can be applied to all use, including Traditional Digital.




